



BUSINESS SET-UP SERVICES



01

Mainland, Free Zone, and Offshore Company Formation

The UAE is divided into different "economic zones." Choosing the right one depends on where your customers are.

Dubai Mainland: Ideal if you want to trade directly with the local UAE market (e.g., retail, restaurants, or local services). It offers the most flexibility for office locations and government contracts.

Dubai & Sharjah Freezones: These are "special economic zones" (like DMCC in Dubai or SHAMS in Sharjah). They are perfect for startups and international traders because they allow 100% foreign ownership and often have lower setup costs. However, you generally cannot trade directly within the UAE mainland without a local agent.

Activity Consultation: This is the most critical step. The UAE has thousands of specific "activity codes." Choosing the wrong one can lead to bank account rejections or fines. Boston helps match your business model to the correct legal activity.



02

Accounts & Taxation

The UAE is no longer a "tax-free" haven in the way it used to be. Recent laws have made professional accounting mandatory.

Bookkeeping & VAT: If your revenue exceeds AED 375,000, you must register for VAT (5%). Boston handles the quarterly filings to ensure you don't get hit with heavy late-submission fines.

Corporate Tax: As of 2023/24, a 9% Corporate Tax applies to profits over AED 375,000. All companies (even those in Freezones making zero profit) are now required to register for Corporate Tax.

Dashboards & Reporting: Instead of just "doing the math," they provide interactive dashboards so you can actually see your profit margins and cash flow in real-time.



03

Legal Attestation & Other Services

These are the "paperwork" services that often cause the most delays for expats.

Attestation Services: To get a business license or a residency visa, your home-country documents (like degrees or marriage certificates) must be "attested" by the Ministry of Foreign Affairs (MOFA). Boston handles this logistics chain for you.

Trademark Registration: Essential for protecting your brand name in the Middle East so competitors cannot "squat" on your name.

Translation: All official legal documents in the UAE must be in Arabic. Boston provides certified legal translations that are accepted by UAE courts and ministries.



PRO SERVICES



01

Government Liaison

We act as your official representative (PRO) before UAE ministries and authorities. Instead of you standing in line at a government building, we handle the interaction.



Key Authorities: We coordinate with the DED (Department of Economy and Tourism), MOHRE (Ministry of Human Resources & Emiratisation), GDRFA (Immigration), and the Ministry of Foreign Affairs.

The Benefit: We speak the "technical language" of the ministries and stay updated on the constantly changing UAE laws, ensuring your company stays in good standing.

02

Permits

Many business activities in the UAE require special "External Approvals" or permits beyond just a basic license.

Examples: If you are opening a restaurant, you need Municipality and Food Safety permits. If you are in healthcare, you need DHA/MOH permits.

Our Role: We identify which secondary permits your specific business activity needs and manage the application process so your operations aren't delayed by missing paperwork.



03

Trade License Renewal

In the UAE, trade licenses must be renewed annually. Missing the deadline results in monthly fines (often starting at AED 200/month) and can eventually lead to your bank account being frozen.



The Process: Boston manages the Ejari (tenancy contract) verification, ensures your insurance is updated, and processes the payment voucher with the government.

Proactive Reminders: Most firms like Boston track your expiry dates and start the renewal process 30 days early to avoid any "blacklisting" or penalties.

04

Permits

This is the "heavy lifting" of administrative paperwork. It includes everything required to keep your staff and office legal.

Quota Management: Applying for the number of visas your office size allows.

Establishment Cards: Issuing and renewing the cards that allow your company to hire staff.

Medical & Emirates ID: Coordinating the typing and scheduling for employee residency.

Amendments: If you want to change your business partner, add a new activity, or change your manager, they process the legal "Amendment" to your license.
